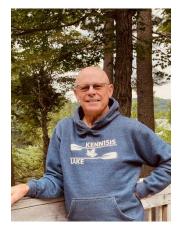

Increasing Revenues for future Budgets



- Budget continues to run a deficit and past surpluses are almost used up
- Reserve fund of \$26,000 is to be set aside for emergencies or unexpected events (best practice is one years' operating funds)
- The KLCOA has a fiscal responsibility to balance our revenue and expenses and has determined that a membership fee increase and increasing sponsorship revenue are the best options to meet annual budgeted expenses
- Will allow for additional programming and increases in expenses for the next few years

MEMBERSHIP DUES

- Dues were \$40 with \$5 discount for paying before Mar 31
- Last KLCOA increase was \$10 in 2015
- 30 local lake associations current dues range from \$20 to \$75

Announced at Spring Meeting 2023

BOARD APPROVED INCREASE EFFECTIVE 2024

- Increased by \$10 to \$50
- Eliminated early bird discount

2023 Financial Statements and 2024 Budget



• KLCOA budget philosophy:

- Over time, surpluses and deficits should balance each other out. The goal is essentially zero-based budgeting.
- During the budget process, we are typically conservative on revenue projections
- Best practice is to have one year's operating funds as a reserve
 - What did this mean for 2023? A budget surplus in operating.
 - What does this mean for 2024? A small planned deficit in operating with a cash flow transfer to reserves.

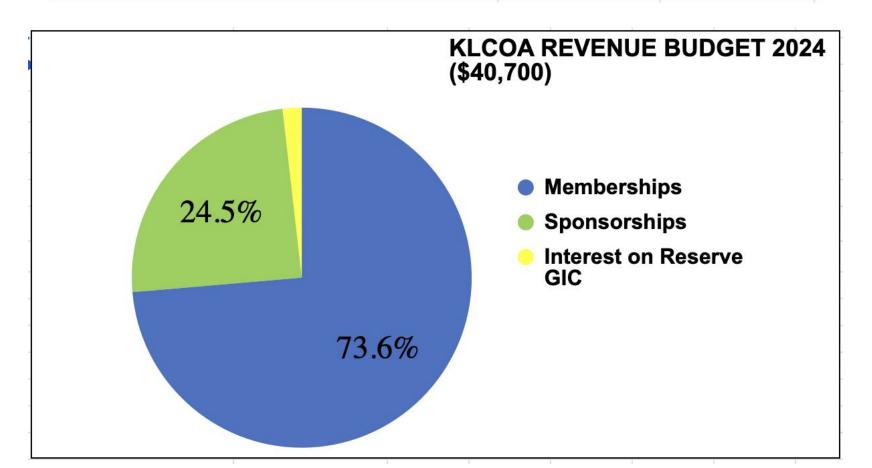
Notes to Financial Statements:

- Short-term investments consist of cash which is surplus to current needs. They are held as GICs at CIBC.
- KLCOA owns seven separate parcels of real estate for the use of its members. All properties have been donated to the Association. No value has been assigned to these properties. Property taxes are paid on three (3) of the properties with the other four (4) being tax exempt.
- Deferred Member Revenue consists of future year member contributions collected prior to year-end.
- Consistent with best practices, KLCOA maintains a general reserve to cover future uncertainties including unexpected expenditures. The reserve approximates one year's operating revenue and been built up over a number of years.

Treasurer's Report: 2024 - Budget Revenue



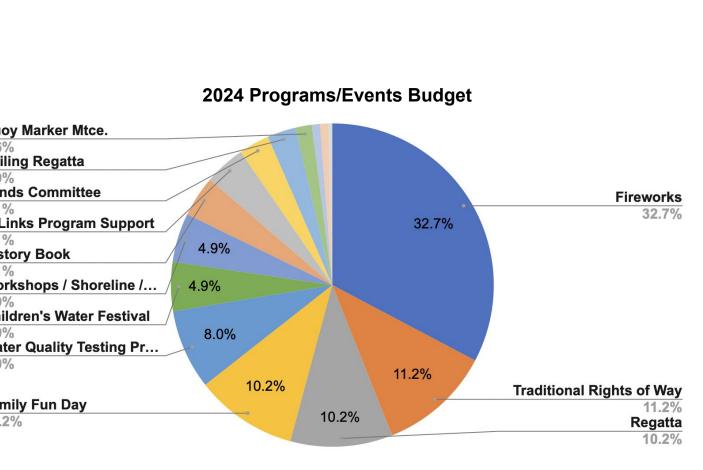

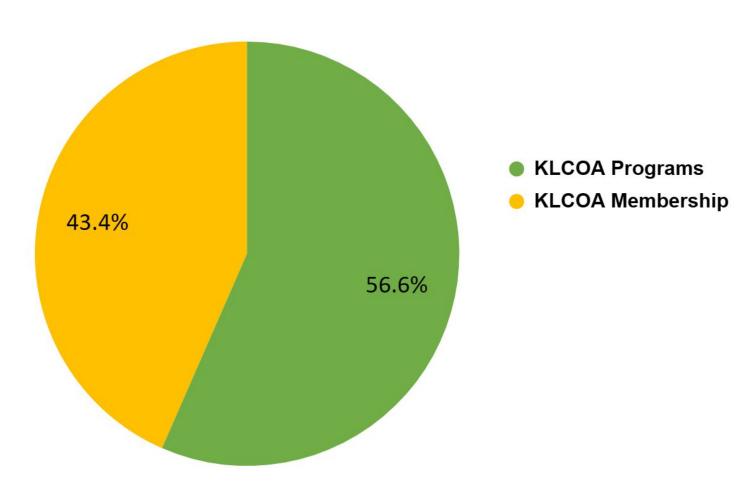

KLCOA PROGRAMS and MEMBERSHIP BUDGET 2024 (\$43,223)



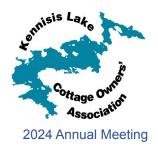

Motion to Waive Audit and Review Engagement



- The KLCOA has annual revenue of less than \$100,000 and we are not a Public Benefit Corporation therefore the Ontario Not for Profit Corporations Act (ONCA) allows us to waive both an audit and a review engagement.
- Approval to waive both an audit and review engagement requires an extraordinary resolution, which is approval from at least 80 per cent of the votes cast at an annual or special meeting of members.
- The cost to do a review engagement or audit can range anywhere from \$2,000 to \$4,000 and up.
- The KLCOA's annual total revenue for 2023 was \$35,000 and 2024 budgeted revenue is \$41,000.

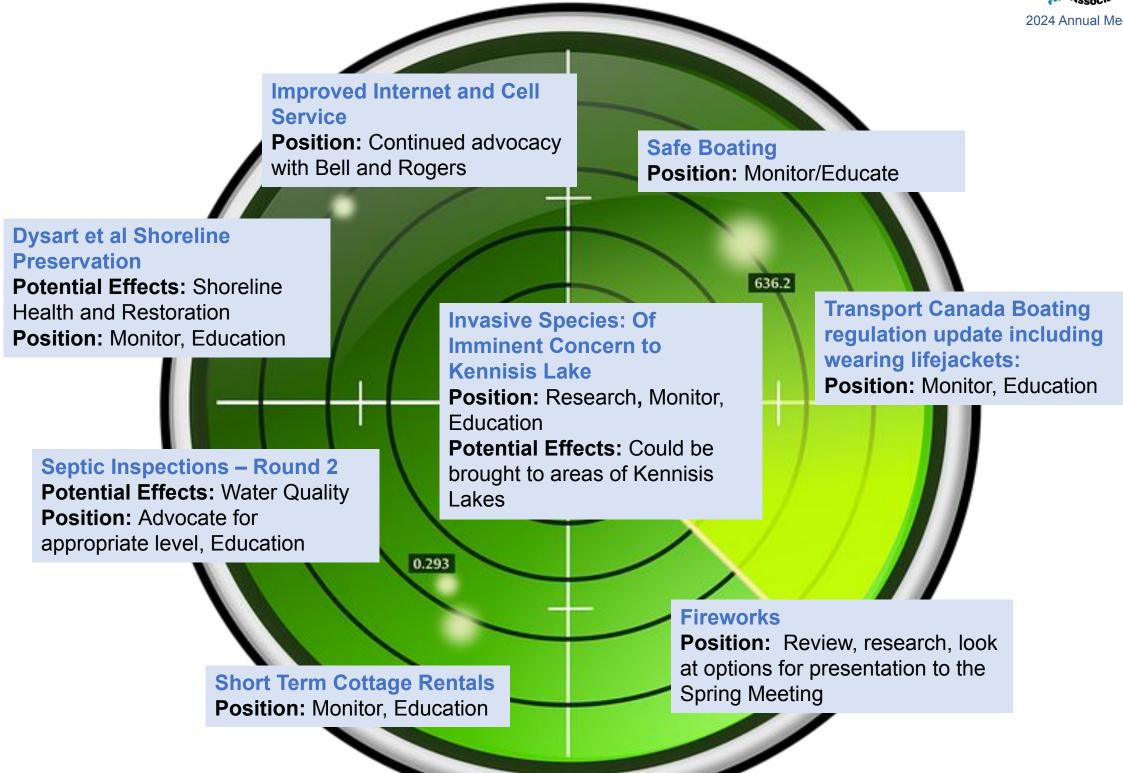

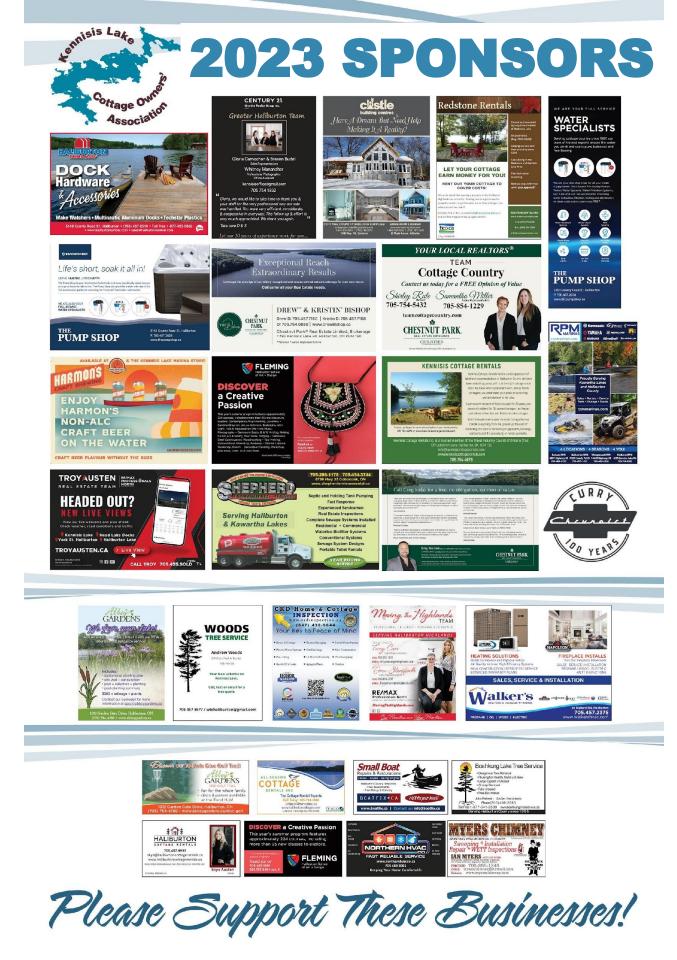
